II. ADMINISTRATIVE MATTERS

2.1 Ratification of DPC minutes for the post of Assistant

2.1.1 A DPC meeting was held on 15.12.2022 at 2.00 p.m. to consider promotion from Junior Assistant to the post of Assistant to eligible candidate. The DPC recommended the promotion as per approved roster and five year APAR and vigilance clearance and one week training to Shri Mangal Singh Pundir as Assistant under UR Category.
